# **Question 1:**

#### **Inventory Management at EAC airline Company**

As the EAC airline company is required by law to perform a complete inventory of goods every two years, the company needed a reliable and innovative solution to manage the inventory efficiently while maintaining data accuracy. They were also using the conventional storage systems. The company preferred the system that is based on sequence, activity level, and activity to space levels which supports ease of retrieval. This company had problematic reasons for carrying inventory in this company. An airline company that operates multiple warehouses for aviation parts and consumables, managed by both national and private sector companies, required the support of RGIS. These warehouses do not share a unified warehouse management system (WMS), resulting in incomplete and inconsistent data for inventory control. Additionally, some parts labels lacked critical information, making the inventory process challenging. After several years of considering other providers, the airline company selected RGIS for its innovative Vision OCR technology, which provided a competitive edge in automating data collection. It also held different functional types of inventories. This technology was crucial for overcoming the challenge of incomplete information on part labels and enabling more efficient inventory counts.
